

cSPACE Projects – “Capture Culture Days at cSPACE King Edward Photo Contest”

1. Eligibility

“The Capture Culture Days at cSPACE King Edward Photo Contest” (the Sweepstakes) are open to legal residents of Alberta who are at least eighteen (18) years old at the time of entry. Employees of cSPACE Projects, tenants of cSPACE King Edward and other companies associated with the promotion of the Sweepstakes, and their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Sweepstakes is subject to federal, provincial, state, and local laws and regulations.

2. Sponsor

The Contest begins on September 29, 2017 at 10:00 a.m. MST and ends on October 1, 2017 at 6:00 p.m. MST (the Sweepstakes Period). Entries that are submitted before or after the Sweepstakes Period will be disqualified. Submissions will be accepted for the duration of the Sweepstakes via Instagram and Facebook.

5. How to Enter:

Capture your Culture Days experience at cSPACE King Edward (Sep 29-Oct 1) in 5-10 photos and share using the hashtags #cSPACEKingEdward AND #culturedays. Please also tag or mention @cSPACEKingEdward and ensure your Instagram Profile and Facebook Post Setting are set to “Public” so we can properly view your entry.

Facebook: Share your 5-10 images in a single post or album and tag @cSPACEKingEdward. Ensure your post settings are PUBLIC.

Instagram: Share you 5-10 images in a single multi-pic post tagging or mentioning @cSPACEKingEdward and including the hashtags #cSPACEKingEdward and #CultureDays. Ensure your Profile is set to PUBLIC.

(i) All entries become the property of Sponsor and will not be acknowledged or returned.

(ii) The entry must fulfill all Contest requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of the Sponsor.

(iii) You may enter only once. You must provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules.

Any and all prize-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of Winner. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by Winner is permitted.

Acceptance of prize constitutes permission for Sponsor to use Winner’s name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law.

7. Odds: The odds of winning depend on the number of eligible entries received.

8. Winner Selection and Notification: Winner will be selected by third-party judging under the supervision of the Contest Sponsor. Winner will be notified by comment or direct message within 24 hours following selection of Winner. The Contest Sponsor shall have no liability for Winner’s failure to receive notices due to spam, junk e-mail or other security settings or for Winner’s provision of incorrect or otherwise non-functioning contact information. If Winner cannot be contacted, is ineligible, fails to claim the prize within 3 days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate Winner selected. - 1) Originality & Creativity
- 2) Visual Impact
- 3) Technical Proficiency
- 4) Overall Storytelling (photo + caption)

Judging will take place on Monday, October 2 at or around 12:00 p.m. MST. The Sponsor will attempt to notify the potential winners via a Reply to the Comment entry on Facebook post. If the potential winner cannot be contacted within three (3) days after the date of the first attempt to contact him/her, the Sponsor may select an alternate potential winner in his/her place at random from the remaining non-winning, eligible entries.

10. Winner Notification

The potential winners will be notified by comment and Facebook post. If a potential winner cannot be contacted, potential winner forfeits prize. If the potential winner is at least 18 but still considered a minor in his/her jurisdiction of residence, Sponsor reserves the right to award the prize in the name of his/her parent or legal guardian and fulfill any requirements imposed on winner set forth herein. Potential winners must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. In the event that the potential winner is disqualified for any reason, Sponsor will award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. Only three (3) alternate drawings will be held, after which the prize will remain unawarded. Prizes will be fulfilled 1-2 weeks after the conclusion of the Sweepstakes.
